<Cash Flows>

- Net cash provided by operating activities was 216.1 billion yen due to operating revenue and dividend income, despite the increases in working capital and others
- Net cash used in investing activities was 75.1 billion yen due to the outflow of a capital expenditure in overseas businesses and others, despite the inflow from sales of investment securities
- As a result, free cash flow was an inflow of 141.0 billion yen

<Financial Position>

- Net interest-bearing debt increased 56.6 billion yen from the end of the previous fiscal year to 1,744.5 billion yen, mainly due to the optional repayment for the perpetual subordinated loan(*4) and dividend payment despite the increased free cash inflow
- Total equity increased 50.1 billion yen from the end of the previous fiscal year to 1,957.6 billion yen, mainly due to an increase in retained earnings by net profit accumulation, despite a decrease by the optional repayment for the perpetual subordinated loan(*4)
- As a result, net DE ratio stood at 0.89 times, up by 0.01 points from the end of the previous fiscal year

*4 The Company made an optional repayment of a total of 100.0 billion yen on August 16, 2021, for the perpetual subordinated loan (total amount: 250.0 billion yen) which the Company financed on August 16, 2016. To fund the optional repayment, the Company issued corporate hybrid bonds with a 75.0 billion yen total value (subordinated debt) on March 4, 2021, and withdrew 25.0 billion yen in total on August 16, 2021, from the hybrid loan facility (a subordinated commitment loan) with a total aggregate principal amount of 25.0 billion yen. Perpetual subordinated loans are classified as equity instruments under IFRS. Therefore, as a result of the above repayment, total equity decreased 100.0 billion yen.

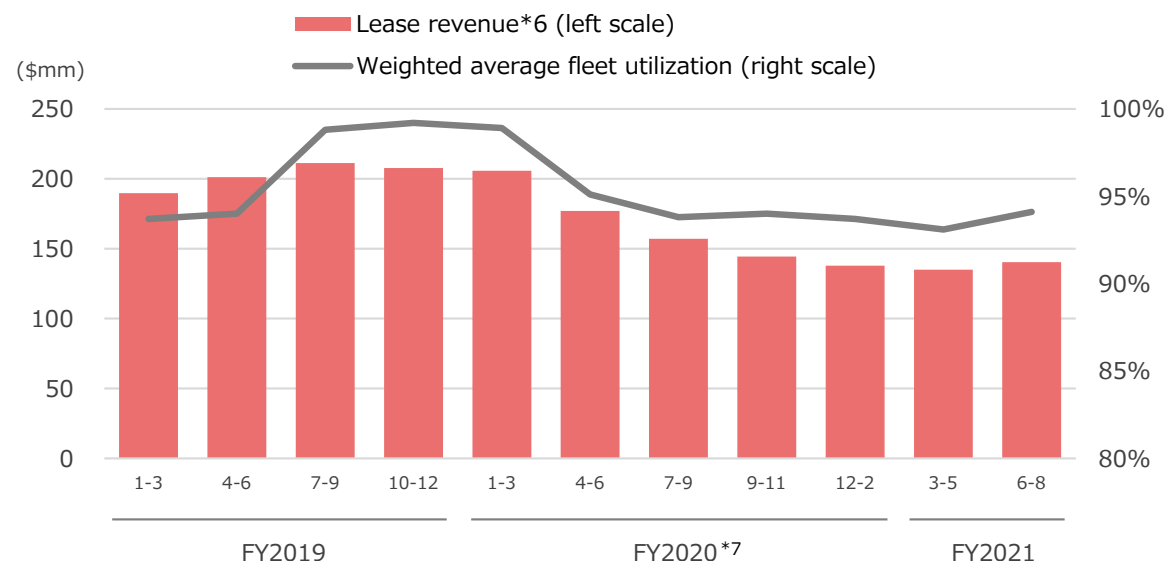

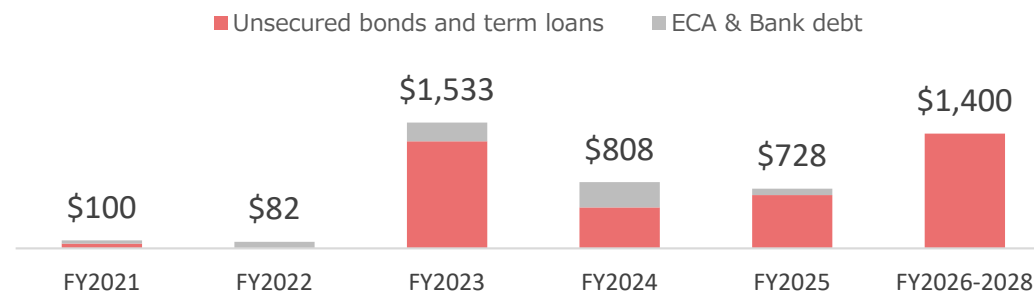

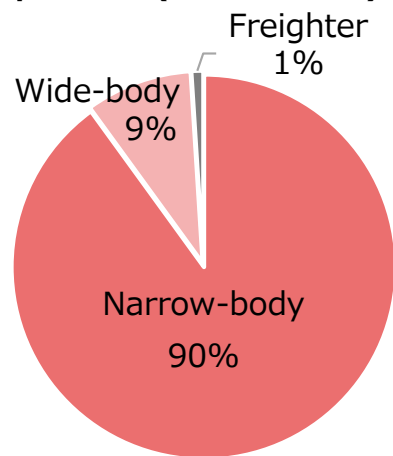

<Debt Maturity Profile (\$mm)>

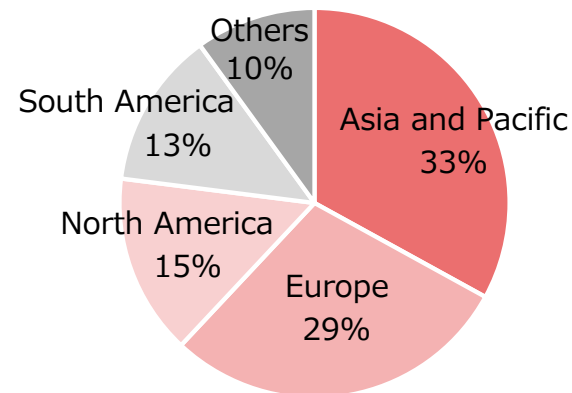

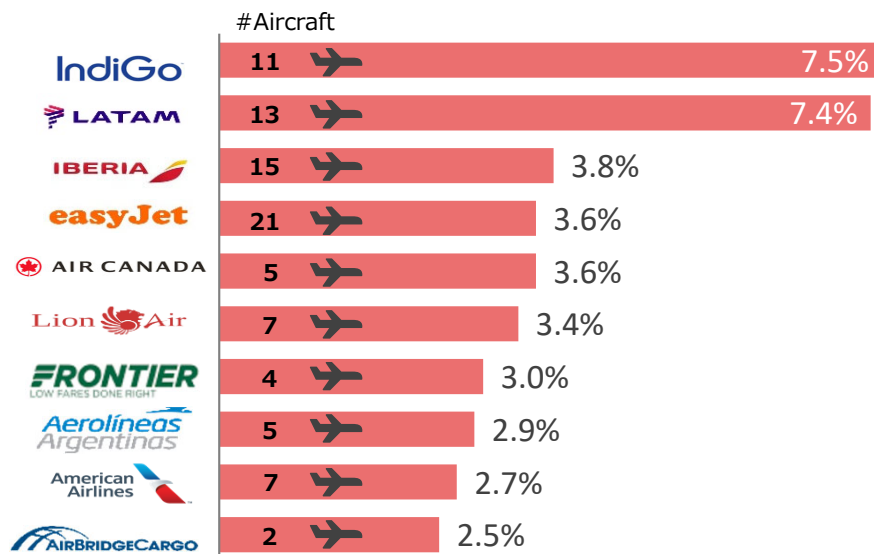
Portfolio Composition (# of Aircraft)



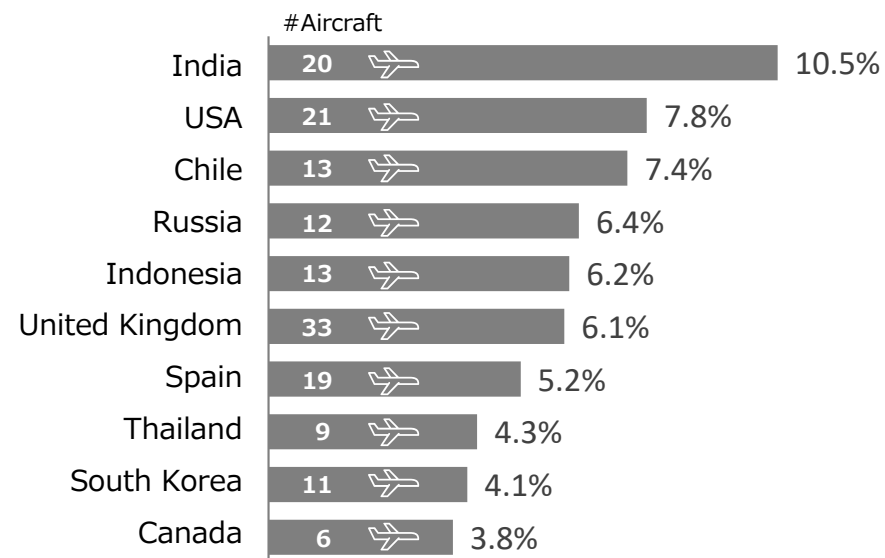
Regional Exposure*2
