Notice Regarding the Progress of Share Repurchases

Marubeni Corporation, at the meeting of the Board of Directors held on November 2, 2023, resolved to repurchase shares of its common stock pursuant to Article 156 of the Companies Act of Japan, as applied pursuant to Paragraph 3, Article 165 of the Act. The progress of the share repurchases is as follows:

- (2) Total number of shares repurchased: 1,313,100 shares
